As an exhibitor, you are required to carry commercial general liability insurance including products and completed operations, contractor's personal injury and blanket contractual liability insurance at limits of at least \$1,000,000 per occurrence and \$2,000,000 aggregate. These coverages must be evidenced by a Certificate of Insurance with a 30-day notice of cancellation provision to the holder. Coverage should begin from your first move-in day (January 17, 2026) and last through your last available move-out day (January 17, 2026 – January 27, 2026) and name NMMA, New York Boat Show, and the Javits Center as additional insureds. The Certificate of Insurance must be submitted to the NMMA prior to the first day of move-in. You can upload your certificate through the NMMA Portal.
